1. Please **do not** come early to use the rented facility. Make sure to rent the facility for the hours needed to arrive and set up for your event. Please exit the park no later than seasonal closing time.
*****PARK GATE WILL BE LOCKED AT CLOSING TIME*****
2. Please **do not** stay past your rental time. You and your guests must leave the facility on or before your time is up.
3. All reservations **Must** be cancelled within 48 hours to receive a refund, or to reschedule for a different date and time.
4. The Kitchen holds a maximum of **25 people**, per fire and safety codes. The renting of the Kitchen does not include the gym. The halls and front area must remain clear for public use.
5. Playground equipment and the areas surrounding the facility are not rented. They are for public use, including the rental party.
6. Decorations for events are placed at your own risk. All Decorations including tape, pushpins, staples, etc. must be removed. *Any costs incurred by the Park for removal of such items, or repairs to park property, will be charged to the rental party.*
7. **Do not** place grills anywhere on gazebos or shelters.
8. Please place all garbage in cans at the rental site prior to leaving.
9. No alcoholic beverages are allowed in the park.
10. **DO NOT REMOVE TABLES** from the shelter and gazebos. If any changes are needed, notify the Park Personnel.
11. **No weddings** are to take place on the docks. Docks must remain open to the public during park hours.
12. **NO FOOD OR DRINKS** are allowed in the Gym. **NO BOUNCE HOUSES IN GYM. PLEASE BRING GYM SHOES** to wear when renting gym. **Shoes worn in from outside will damage gym floor. If there is damage floor or gym facility, the rental party will be responsible for repairs.**
